- A. Community presentations
- B. TEA party: Approximately 100 people present; August 12, 2010
 - 1. Comments: What if internet goes down; Why add more technology; keep things as they are; Where is funding coming from?
- C. Republican Party: 20 plus present; August 19, 2010
 - 1. Very little comment. Interest in allowing voters to vote at any poll place

I. Polling Places: Announcements were posted on the doors of all eight polling places

II. Implementation

- A. We chose to use all eight regular polling places as Vote Centers
- B. Air cards from Verizon Wireless were purchased to use at five of the polling locations: 101; Madison County Library: 102; Midway Community Center: 203; Lakehouse at Lake Madison: 204; Elwood Baptist Church: 306; Normangee Community Center
 - 1. Air Cards were tested and worked at all sites before making the final decision to go forward with the project
 - 2. When setting up on the day before election all sites worked fine except for Elwood Baptist Church. Air Card could not acquire a signal. The local wireless internet service provider set up a receiver at the Church and all sites worked.
- C. Polling locations at Madison County Courthouse were connected via Madison County's wireless internet. [305 and 407]
- D. Precinct 408 polling location was in North Zulch Elementary School and used the wired internet service of the school
- E. The software used was VoteSafe by Votec.
- F. Hardware was eight Dell 11" notebooks for election day and two 15" notebooks for early voting

- 2. The largest gains [+37; 102 +51; 306 +54; 204 and +126; 408 are predominately rural areas][57 voters from these precincts voted in polling locations 305 and 407, located in the county court house]
- 3. The smallest gains/losses [-8; 203 -5; 407 +6; 101 and +13; 305 are attached to the city of Madisonville][only one of these voters voted outside of the city, a poll worker who worked in 102 location]
- 4. 2006 and 2008 elections were self contained elections [Voter had to vote in his precinct polling place]

C. Observations

- 1. *The statistics listed above do not include about 18-20 voters who were not processed through VoteSafe due to being inadvertently left off the voter registration roll at the time they were submitted to VoteSafe. Most of those voted in county court house.
- 2. County Court Room [central location county] had 7 or more voters from each precinct.
- 3. District Court Room [central location in county] had voters from all other precinct except 204
- 4. Library and Midway had next most voters out of home precinct. Midway had 21 voters from precinct 204. Many of pct 204 voters have to travel through Midway to get to Elwood [204]
- 5. Normangee [isolated in nw corner of county] had no voters other than 306 precinc voters
- 6. Elwood had only one outside vote. Isolated area.
- 7. North Zulch had only six outside voters. Expected North Zulch would have had more voters from precinct 306. Probably need more publicity in that area.
