Voter Registration Eligibility Requirements



Eligibility

An eligible individual must:

- be 18 years of age or older;
- be a United States citizen; and
- be a Texas resident.

An eligible individual must not:

- have been finally convicted of a felony; and if so, have completed their term of incarceration, parole, or supervision, or completed a period of probation ordered by any court
- have been declared totally or partially mentally incapacitated without the right to vote by a court of law.



Determination of Eligibility

- An employee of a voter registration agency **may not** make any determination about a person's eligibility for registration other than whether or not a person is of voting age or a U.S. Citizen.
- A person's age and citizenship status may be determined **only if** such information is filed with the agency for purposes other than voting.
- A person must be offered voter registration assistance **even if** the applicant's age and/or citizenship status cannot be determined.

Reviewing of Applications

- Agency employees may review applications for completeness only in the applicant's presence. If the agency employee determines that the application does not contain all the required information and the required signature, the agency staff may return to the applicant for completion and resubmission. (TEC § 20.032)
- If a question arises concerning voter registration that the agency employee cannot answer, the employee must provide:
 - The toll-free number for Elections Division at the Office of the Secretary of State (800-252-8683).
 - The telephone number of the voter registrar to whom registration applications are submitted within the county. (TEC § 20.008)

If an applicant declines the voter registration application, a declination of registration form should be **completed and signed** by the applicant.

If the applicant refuses to sign the declination form, the agency employee must include a notation of that fact on the form.

Declination forms must be preserved for at least 22 months after the date of signing either in the applicant's file at the agency or in a separate declination file.

Declinations are **confidential** and may be used only for voter registration purposes.

When is the Registration Effective?

- The voter registration will become effective thirty (30) days after it is received by the agency employee, or on the voter's 18th birthday, whichever is later.
- The date of submission of a completed voter registration application to an agency or employee is considered the date of submission to the county voter registrar for the purpose of determining the effective date of registration only (TEC §20.033).

How Long is Registration Effective?

- The registration will be automatically renewed every even-numbered year unless:
 - The voter moves to another address;
 - The voter receives a final felony conviction and has not completed the sentence, probation, or parole or been pardoned or otherwise released from the resulting disability to vote (note: "deferred adjudication" does not constitute a "final felony conviction"); or
 - The voter has been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote.

Deadline For Voter Registration

- Texas law requires eligible voters to register by the 30th day before Election Day in order to vote in that election.

Timeline for Returning Applications

- A voter registration application **must** be delivered to the voter registrar not later than the **5th day** after the date the application is submitted to the employee. (TEC §20.035(b))

Reminders



Reminders – State Agencies Must

Offer voter registration services during any service that is provided by the state agency.

Inform clients that registering to vote is voluntary and has no effect on the provision of agency services.

Assist applicants with completing voter registration forms when help is requested.

Provide voter registration forms in multiple languages and accessible formats to meet the needs of a diverse population.

Train staff regularly to ensure they understand voter registration procedures and requirements.

Reminders – State Agencies Cannot

Refuse to offer voter registration services to individuals applying for services or assistance.

Discriminate against applicants based on race, political affiliation, disability, language, or another characteristic.

Attempt to influence political or party choice while assisting with registration.

Display political party material or messages in the voter registration area.

Require additional documentation or impose extra steps beyond what is legally allowed for registration.

Neglect to transmit completed voter registration applications to the voter registrar's office within the required timeframe.

Fail to provide assistance with completing the registration form if requested.
